

S2Focus™ Software Single Seat License Agreement

IMPORTANT-READ CAREFULLY: This license agreement is a legal agreement between you (Licensee) and General Dynamics C4 Systems, Inc., (General Dynamics C4 Systems), which includes computer software and associated media and printed materials, and may include “online” or electronic documentation.

By installing, copying or using the Software, you agree to be bound by the terms of this license agreement. If you do not agree with the terms of this license agreement, promptly return the unused Software to the place from which you obtained it for a full refund.

The copyrights laws and international copyright treaties, as well as other intellectual property laws and treaties, protect this Software.

1. License Grant. Subject to mutual acceptance of these terms, General Dynamics C4 Systems grants to Licensee a non-exclusive, transferable license to use the S2Focus Software, including software documentation provided with such software (hereafter “Software”), on a single computer (“Seat”).

2. Ownership. General Dynamics C4 Systems and / or its licensors retain ownership of the Software including all patents, copyrights, and other intellectual property rights.

2.1 Licensee may transfer its rights under this license as long as the receiving party agrees to be bound by the terms of this agreement, and the original Licensee no longer uses the Software (including all component parts, the media, and printed materials and this license agreement.

2.2 Licensee agrees not to, in whole or in part, reverse engineer, decompile, disassemble, modify, rent, lease, or create derivative works of the Software for any purpose or in any manner.

2.3 Licensee agrees that (1) no license, right or interest in any trademark, trade name, or service mark of General Dynamics C4 Systems, its licensors or any third party is granted under this Agreement; (2) Licensee is not permitted and shall not remove or destroy any of the Software’s proprietary, trademark or copyright legends or markings and (3) all existing and future copyright, patent, trademark, or other intellectual property rights arising out of or related to the Software shall remain the sole property of General Dynamics C4 Systems and / or its licensors.

3. Scope Of Use. This software may only exist on one (1) Seat.

4. Term and Termination. Licensee may use the Software from the date received for a ninety-nine (99) year time period, unless terminated as provided herein.

4.1 General Dynamics C4 Systems may terminate this Agreement immediately should Licensee materially breach any of the provisions of this Agreement or take any action in derogation of General Dynamics C4 Systems’ rights to the Software licensed hereunder. In addition, General Dynamics C4 Systems may terminate this Agreement immediately should the Software, or any portion thereof, become, or in General Dynamics C4 Systems opinion be likely to become, the subject of a claim of infringement of a patent, trade secret, copyright, mask work right, or other proprietary right.

4.2 Upon expiration or termination of this Agreement, Licensee shall immediately discontinue all use of the Software and, unless otherwise instructed by General Dynamics C4 Systems, within thirty (30) days after such expiration or termination, Licensee shall destroy all such Software and certify to General Dynamics C4 Systems in a writing signed by an authorized representative of Licensee that all such Software has been destroyed.

4.3 The rights and obligations under this Agreement, which by their nature should survive termination, will remain in effect after expiration or termination hereof.

5. Maintenance and Support. At Licensee’s option, maintenance and support may be purchased on a yearly basis from General Dynamics C4 Systems through the S2Focus Software Maintenance and Support Agreement. An active Software Maintenance and Support agreement is required for product updates, technical support, bug fixes, and

license transfers. If the Software Maintenance and Support agreement is not maintained on a yearly basis, a fee of at least 1 year of Software Maintenance and Support will be imposed on the purchaser in addition to the maintenance costs requested for the current year.

6. Limited Warranty. General Dynamics C4 Systems warrants that under normal use, the Software shall perform the functions specified in its documentation. If the Software does not conform to its documentation such that its functional performance is significantly affected and General Dynamics C4 Systems is notified in writing within ninety (90) days from the date of purchase along with a copy of the receipt of purchase, General Dynamics C4 Systems shall have the option of refunding the purchase price or replacing the Software as Licensee's exclusive remedy. THIS WARRANTY IS EXCLUSIVE AND IN LIEU OF ALL OTHER WARRANTIES WHETHER STATUTORY, EXPRESS, OR IMPLIED (INCLUDING ALL WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE).

7. Liability. IN NO EVENT SHALL GENERAL DYNAMICS C4 SYSTEMS BE LIABLE FOR ANY SPECIAL, INCIDENTAL, PUNITIVE, INDIRECT OR CONSEQUENTIAL DAMAGES, (INCLUDING LOSS OF ECONOMIC ADVANTAGE, BUSINESS, PROFITS, DATA OR INACCURACY OF DATA), IN CONNECTION WITH OR ARISING OUT OF THIS AGREEMENT OR FROM USE OF SOFTWARE, WHETHER OR NOT GENERAL DYNAMICS C4 SYSTEMS HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES AND REGARDLESS OF THE FORM OF ACTION OR LEGAL THEORY (WHETHER IN CONTRACT OR IN TORT, INCLUDING STRICT TORT LIABILITY, OR BASED ON A WARRANTY) UNDER WHICH THE LIABILITY MAY BE ASSERTED.

8. Government Rights In Commercial Software. If acquired under FAR policy (52.227-19), the U.S. Government shall obtain Restricted Rights in this Software. If acquired under DFARS policy (227.7202), the U.S. Government is granted only the commercial rights given above in this License.

9. Export Compliance. Licensee agrees that it will not in any form export, re-export, ship, or divert or cause to be diverted, directly or indirectly, the Software to any country for which the United States Government, any agency thereof, or any other sovereign Government, at the time of export or re-export, requires an export license or other governmental approval without first obtaining such license or approval.

10. Applicable Law. The laws of the State of Arizona, excluding its conflicts of law principles, shall govern this Agreement. Licensee consents to the exclusive jurisdiction of the State of Arizona for all matters related to this Agreement.

11. Severability. If any of the provisions, or portions thereof, of this Agreement are found to be invalid under any applicable statute or rule of law, then, that provision notwithstanding, this Agreement shall remain in full force and effect and such provision or portion thereof shall be deemed omitted.

12. Entire Agreement. By using the Software, Licensee acknowledges that this agreement has been read and understood and agrees to be bound by its terms and conditions. Licensee further agrees that this Agreement sets forth the sole and entire understanding with respect to this Software Site License, and merges and supersedes all prior oral and written agreements, discussions, and understandings, express or implied, concerning all matters related thereto. This Agreement may not be modified, amended or cancelled, in whole or in part, except by written agreement signed by both parties.
